Did You Know or Have You Thought About?

- **Publicly traded stocks or bonds** make excellent gifts and easily can be transferred to UMD. If the securities have appreciated, you not only receive the benefit of the full fair market value as a charitable income tax deduction, you also avoid capital gains tax if you have owned the securities for more than one year.
- **A bequest in a will or trust** stipulates that the entire amount or a percentage of your estate be given to the university after your lifetime. Your bequest may be designated to a specific college, school or program, to a faculty endowment or scholarships, or it may be unrestricted and used where needed most. Gifts from your estate to UMD are exempt from estate tax.
- **Retirement fund assets** would be heavily taxed if given to an individual. After your lifetime, the remainder of your retirement fund can be assigned to UMD as an unrestricted gift or designated for a college, school, program, faculty endowment or student scholarships.
